| 922 | <b>New Volunteer Conservation fund:</b> Beggars Bush is the main project highlighted but it was agreed it would need a large investment. | 923 | Malthouse Meadow: Cllr Glynn-Davies said that the coppicing had started by the entrance and it had been very successful. There had been a recent very positive meeting with lots of ideas of how to develop the site further. Ideas included a fenced wildlife pond, a roundhouse and wildflower meadow. Cllr Glynn-Davies is meeting with the Rangers and the headteacher of Sompting Village Primary very soon to see if the children could design a display board with ideas for its future. There is a need to work more closely with residents surrounding the site and to keep them informed of work being done. Maybe consider a leaflet to those residents.  Sustainable Sussex are also looking into extra funding.  Sustainable Sussex are to take the lead - managing volunteers, risk assessments and the insurance.  Sompting Estates are happy that an option of entrances into the Community Orchard may be possible and make the area more accessible to dog walker. | 927 | <b>Multi Agency Working Group – Anti Social Parking.</b> Although WSCC are also doing a campaign re anti-social parking, it was agreed that the SPC still wanted to do a 'Community Lead' campaign in the local area near the school and Test Road. | 928 | <b>Sustainable Transport – North Sompting –</b> Cllr Godley requests this be deferred to the next agenda as she has a meeting with WSCC on 13 <sup>th</sup> March to investigate the need and discuss what options are available. | 929 | Adur Homes – Millfield – Assistant Clerk reported that SPC are still awaiting the full project plan from ADC and had been chasing this. It was noted however that this only covered external works to Millfield. Cllr Mear said originally the £1.8 million allocated, was for Millfield alone, but now it was being shared with the larger estate at Bushby Close. It was mentioned that there are families some with many problems at Millfield and it was still thought a designated play area was a priority. | 930 | Halewick Lane – Flooding Cllr Holland gave a brief history to the committee saying that the flooding had affected her property in Nelson Close as far back as 1991 and the last incidence in August 2018 had been nearly as bad. There had been a public meeting on 20 <sup>th</sup> February with a number of members of the public attending. Problems highlighted were - clay capping, geology, landfill, site changing hands and site management not being kept up to date. Further to the public meeting on 20 <sup>th</sup> February, a round table meeting took place with most stakeholders present. Some important action was identified. Mr Tim Laughton MP has stated that a large amount of money may need to be spent by WSCC to ensure that the problem is tackled once and for all. |                         |  |  |  |  |
